#### **Check for Eligibility**

Before you begin, confirm that your business is a NYSEG or RG&E small business customer. See the eligibility criteria below for more information or call **888.316.8023** to see if your business qualifies.



Visit nyseg.com/sbrp or rge.com/sbrp for a list of available rebates and all program resources.



#### Find a Trade Ally

You can either work with your own contractor or find a registered trade ally by visiting our website. Registered trade allies are experts in the program and can help you through the rebate process.



#### **Identify Project Type**

Together with your contractor or trade ally, determine if your project qualifies for a rebate.

NOTE: Energy efficient equipment not covered by the Small Business program may be eligible for Commercial and Industrial rebates. Visit <u>nyseg.com/cirp</u> or <u>rge.com/cirp</u> for more information on C&I rebates. <u>All</u> applications for custom measures <u>require pre-approval</u> prior to the purchase or installation of the equipment.

# **Eligibility Criteria**

Eligible accounts must meet one of the following sets of criteria. Project work scope must not result in a customer exceeding the thresholds listed below.

#### BOTH electricity and natural gas delivered by NYSEG and/or RG&E:

Average monthly demand less than or equal to 110kW on the primary electric account.

Eligible for **all rebates.** 

# ONLY electricity from NYSEG/RG&E:

Average monthly demand less than or equal to 110kW on the primary electric account.

Eligible for **electric measure rebates**.

# ONLY natural gas from NYSEG/RG&E:

Annual total gas consumption less than or equal to 5,000 therms on the primary gas account

Eligible for **electric and HVAC rebates.**
